

**OFFICIAL TERMS AND CONDITIONS
SIZZLIN' SUMMER GEAR GIVEAWAY**

1. **No purchase is necessary.** All entries have an equal chance of winning.
2. **How to enter:** During the promotion period, July 14 – September 30, 2008, drop by any OnPoint branch (Oregon or Washington) to complete and submit an entry form. Entry forms may also be mailed to OnPoint at the above address. Please note – you do not need to be present to win.
3. **Prize Drawing Details.** During the twelve-week promotion, OnPoint will randomly select one (1) winner per week or twelve (12) winners total. Generally, the drawing will be held on Friday of each week. Any mail-in entries will be added to the drawing. Winners do not need to be present to win.
4. **Prizes:** During the promotion period, twelve (12) prizes will be awarded – entries from all branch locations will be combined and drawn at OnPoint's corporate headquarters. Each winner will be awarded one of the following prize packages: car camping package, kayak package, patio furniture set, mountain bike, outdoor grill package, hike and camp package, beach getaway package or road bike. The value of each prize package is \$500-\$1,000. Each prize package will be awarded to the person whose name appears on the entry form selected randomly during each drawing. In the event of a dispute regarding the value of the prize, OnPoint will have the sole discretion in determining the amount and its decision shall be final and binding on all parties.
